Section 1. Section 287-58 of the Code of the Village of Rockville Centre is hereby amended, to read as follows:

“§ 287-58. When effective. This article shall take effect immediately pursuant to the Municipal Home Rule Law and shall remain in effect until July 6, 2023, provided, however, that the Board of Trustees may, by resolution, extend the effective date of this article for one or more additional periods provided that in no event shall this article remain in effect after July 6, 2025.”

Section 2. Effective date. This local law shall take effect immediately upon filing with the Secretary of State pursuant to the Municipal Home Rule Law.
