Section one. Section 263.1(B) of the Code of the Village of Rockville Centre is hereby amended, to read as follows:

"B. Standard for award of purchase contracts to other than the lowest responsible bidder. For purposes of this chapter, "best value" shall have the meaning provided in § 163(1)(j) of the State Finance Law, as amended from time to time. All bid offerings advertised by the Village for the purchase of goods and related service work shall be issued on the basis of lowest responsible bidder, except that "best value" purchasing may be used (a) for any purchase for which the estimated cost is less than \$350,000.00, with prior approval of the Board of Trustees, Village Administrator or Purchasing Agent, or (b) for any purchase for which the estimated cost is at least \$350,000.00 with prior approval of the Board of Trustees. Best value shall not be available for award of purchase contracts needed for the completion of a public works contract."

Section two. This local law shall take effect immediately upon filing with the Secretary of State, pursuant to the Municipal Home Rule Law.
