Trustee Sepe moved the adoption of the following resolution regarding abolishment of the existing Defined Contribution Service Award Program, and the prospective establishment of a Defined Benefit Service Award Program, which was duly seconded by Trustee Baxley. Mayor Murray disclosed that he is a member of the volunteer fire department and is disqualified from voting upon this motion unless three or more members of the Board are similarly disqualified. In the absence of the necessary quorum of qualified voters with regard to this resolution, further discussion of the resolution was tabled to the next Board meeting at which a quorum of qualified voters is present.

> VILLAGE OF ROCKVILLE CENTRE BOARD OF TRUSTEES RESOLUTION

In the matter of abolishing the Villages current Defined Contribution Service Award Program and then prospectively establishing a Defined Benefit Service Award Program for active volunteer firefighter members of the Rockville Centre Fire Department

May 9, 2019

Rockville Centre, New York

Whereas, a proposal has been made to prospectively replace the Village of Rockville Centre's Defined Contribution Service Award Program effectively established by the Village on January 1, 1994, as subsequently amended, with a Defined Benefit Service Award Program for active volunteer firefighter of the Rockville Centre Fire Department.

Now, Therefore, Be It Resolved That:

Section 1. The Board of Trustees of the Village of Rockville Centre, as authorized by Article 11-A of the New York State General Municipal Law, directs that there shall be a public referendum of eligible voters of the Village of Rockville Centre at the same time and place as the general Village election to be held on June 18, 2019, to determine whether the Village Board of Trustees shall:

- amend the defined contribution program effective January 1, 2020 to require a Participant to earn only one year of service credit to have his or her accrued Service Award become fully, 100% vested; and,
- 2. subject to the amendment in paragraph 1, above, abolish effective January 1, 2020 the Defined Contribution Service Award Program ("Defined Contribution Program"); and
- 3. pay to each person who was a participant in the Defined Contribution Program as of January 1, 2020 the entire vested portion of the balance in his or her Service Award Program account; and
- 4. establish a Defined Benefit Service Award Program as described in Section 219 of Article 11-A effective January 1, 2020, to financially reward volunteers for active volunteer firefighter service rendered after December 31, 2019,.

Section 2. All active volunteer firefighter members who are at least 18 years old, shall be eligible to become Defined Benefit Service Award Program Participants. Unless they waive participation, an eligible volunteer shall become a Participant on December 31 of the first calendar year after calendar year 2019 during which he or she earns a year of Service Award Program service credit. The names of the fire companies having volunteer firefighters who are potential participants in the Program are as follows:

- A. Eureka Hook Ladder & Bucket Co. No. 1
- B. Live Oak Engine Co. No. 1
- C. Alert Engine Co. No. 2
- D. Reliance Hose Co. No. 3
- E. Defender Hose Co. No. 1
- F. Woodland Engine Co. No. 4
- G. Floodlight Co. No. 1;

Section 3. The Defined Benefit Service Award Program shall be administered by the State of New York (i.e. the NYS Comptroller or the designee of the NYS Comptroller).

Section 4.Rockville Centre Fire Department active volunteer firefighter members shall have the opportunity to earn pension-like benefits as well as death and disability benefits under the Defined Benefit Service Award Program. The pension-like benefit, shall be a monthly lifetime payment accrued "Service Award" paid to a Participant with payments beginning after attainment of age 65 the "Entitlement Age," but not before a Participant earns at least one year of Service Award Program service credit for a calendar year after calendar year 2019. The monthly lifetime payment accrued "Service Award" shall be equal to \$20 for each year of Service Award Program service credit earned by a participating volunteer. The maximum monthly payment shall be \$600. Post age 65 active volunteers may be paid additional \$20 monthly lifetime service award payments for years of service credit earned after age 65. The participant may select any other actuarially equivalent forms of such monthly lifetime payments offered by the New York State Comptroller. In the event of the death of a Participant who had earned a non-forfeitable right to his or her earned service award before he or she attained the Entitlement Age, a lump sum death benefit shall, upon application, be paid to the Participant's designated beneficiary (or estate if no beneficiary is designated) and shall be equal to the discounted value at the time of death of the actuarial present value of the Participant's accrued Service Award. A Participant, who, before attaining the Entitlement Age shall be awarded benefit payments due to a total and permanent disability by the Social Security Administration or by any entity which pays benefits under

the Volunteer Firefighters' Benefit Law or by any other authority approved by the New York State Comptroller, shall be eligible to be paid a pre Entitlement Age disability benefit payment under the Service Award Program. Such disability benefit payment shall be a lump-sum payment to the Participant equal to the discounted actuarial present value of the Participant's accrued Service Award and be payable upon application by the Participant to and approval of payment by the New York State Comptroller.

Section 5. A Participant's accrued Service Award shall become fully vested (i.e. a Participant shall obtain nonforfeitable right to his or her accrued Service Award) after: he or she earns and does not permanently forfeit Service Award Program service credit for at least five (5) years of active volunteer firefighter service; or, attains age 65 while an active volunteer firefighter member; or, is awarded a Service Award Program total and permanent disability benefit payment.

Section 6.As of December 31 of the year a non-vested Participant ceases to be an active volunteer member of the Rockville Centre Fire Department, he or she shall forfeit any earned service credit and any accrued Service Award. The forfeited service credit and Accrued Service Award of a person who ceased to be an active volunteer firefighter member of the Rockville Centre Fire Department shall be restored if the person again becomes an active volunteer firefighter member of the Rockville Centre Fire Department within five years and subsequently earns at least one year of service credit under the Service Award Program Point System.

Section 7.A year of Service Award Program service credit shall be earned by an active volunteer firefighter for each calendar year after 2019 during which the volunteer earns at least 50 "points" while an active volunteer firefighter member of the Rockville Centre Fire Department for participating in the volunteer firefighter activities set forth by the Village Board of Trustees in the Service Award Program "Point System" as authorized by Section 217 of Article 11-A of the General Municipal Law, and during which he or she agrees to participate in the Service Award Program. A copy of The Point System is attached to this resolution. Copies of this written explanation of the Point System shall be distributed to active volunteer firefighters. The Village Board of Trustees may amend the Point System from time to time provided such amendments are allowable under all applicable statutes, rules and regulations. In the event the Point System is amended by the Village Board of Trustees, a written explanation of the changes shall be distributed to active volunteer firefighter members within 60 days of the date such changes

are adopted by the Board of Trustees.

Section 8.Up to five years of the service credit earned by a Participant in the Rockville Centre Defined Contribution Service Award Program shall be credited for vesting purposes only (see Section 5) in the Rockville Centre Defined Benefit Service Award Program for volunteers who become Participants in the Defined Benefit Service Award Program in accordance with Section 2 of this resolution.

Section 9.Persons who continue to be active volunteer firefighter members of the Rockville Centre Fire Department after they attain the Entitlement Age shall have the opportunity to continue to earn service credit under the Point System. The additional Service Award payment earned by a Participant during a post Entitlement Age calendar year shall commence to be paid as of January 1^{st} in the next succeeding calendar year.

Section 10. Under Article 11-A of the General Municipal Law, the Village of Rockville Centre shall be the Service Award Program "Sponsor".

Section 11. The New York State Comptroller or the designee of the New York State Comptroller shall be the Program Trustee.

Section 12. The annual cost including administration fees of the existing defined contribution program for current active volunteer firefighters can be as much as \$165,000 (\$700 per participating firefighter). The annual cost, first payable in calendar year 2021, of funding the proposed Defined Benefit Service Award Program for current volunteers is estimated to be as much as \$385,000 or \$1,650 per participating firefighter, including the cost of administration. The estimated annual cost to administer the Defined Benefit program for calendar year 2020 is \$8,500. The cost to terminate the existing Defined Contribution Service Award Program is estimated to be \$25,000.

Section 13. The Village of Rockville Centre Defined Benefit Service Award Program benefit payments shall commence to eligible volunteers on or after January 1, 2021 when they and/or their beneficiaries qualify, and apply, for payment in accordance with the Defined Benefit Program provisions set forth by the New York State Comptroller.

Section 14. All other provisions of the Village of Rockville Centre Defined Benefit Service Award Program shall be in accordance with Article 11-A of the General Municipal Law as amended from time to time and all applicable statutes and rules and regulations including

those issued by the Office of The New York State Comptroller.

Section 15. The foregoing provisions of Sections 2 through 14 of this resolution shall take effect only in the event the same are approved at a referendum to be held as described in Sections 1 and 16 of this resolution.

Section 16. The resolution to be voted upon at the said referendum shall read as follows:

"Shall the qualified electors of the Village of Rockville Centre approve the resolution adopted by the Mayor and Trustees on May 13, 2019 pursuant to Article 11-A of the General Municipal Law, to (a) effective January 1, 2020, abolish the existing service award program for members of the Rockville Centre Fire Department as such program previously was approved by the said electors on March 16, 1993, and as thereafter amended with the approval of the said electors, provided, however, that effective January 1, 2020 a participant who earns one year of service credit will obtain a non-forfeitable right to his/her accrued service award, and (b) effective January 1, 2020, establish a service award program which would be administered by the New York State Comptroller or the designee of such Comptroller, and would consist of a defined benefit plan as a service award. The project service award for the defined benefit plan is \$20 per month for each year of service credit, payable for life beginning at age 65. Post age 65 active volunteers may be paid additional \$20 monthly payment lifetime service awards for years of service credit earned after age 65. The annual cost, first payable in calendar year 2021, of funding the proposed Defined Benefit Service Award Program for current volunteers is estimated to be as much as \$385,000 or \$1,650 per participating firefighter, including the cost of administration. The estimated annual cost to administer the Defined Benefit program for calendar year 2020 is about \$8,500. The cost to terminate the existing Defined Contribution Service Award Program is estimated to be \$25,000."

Section 17. The appropriate officers of the Village of Rockville Centre are authorized to, and shall, take the necessary actions to implement and carry out this resolution.

AGREEMENT

AGREEMENT entered into as of this 1st day of June, 2019 by and between the INCORPORATED VILLAGE OF ROCKVILLE CENTRE, a municipal corporation of the State of New York, having its place of business at One College Place, Rockville Centre, New York hereinafter referred to as the VILLAGE, and the ROCKVILLE CENTRE FIRE DEPARTMENT, a statutory corporation organized under the Village Law of the State of New York, hereinafter referred to as the FIRE DEPARTMENT.

WHEREAS, the VILLAGE is authorized, pursuant to Section 4-412, Subdivision 9 of the Village Law of the State of New York to contract with the FIRE DEPARTMENT for the furnishing of fire protection within the VILLAGE and similar services with the FIRE DEPARTMENT; and,

WHEREAS, the VILLAGE desires to make a contract for the protection of public and private property against the hazards of fire and for the extinguishment thereof; and

WHEREAS, the FIRE DEPARTMENT has the means, manpower, ability and facilities for providing such protection and for such extinguishment.

NOW, THEREFORE, in consideration of the sum of ONE HUNDRED SEVENTY NINE THOUSAND FIVE HUNDRED (\$179,500.00) DOLLARS to be paid by the VILLAGE to the FIRE DEPARTMENT, and the

supplying and maintaining by the VILLAGE of the necessary fire apparatus and equipment incidental thereto, together with maintaining in proper repair the fire houses of the several companies and maintaining fire headquarters, the FIRE DEPARTMENT hereby agrees to provide the VILLAGE with fire protection and emergency ambulance service within the full at its disposal, and means undertakes the extinguishment of any fires that occur within the VILLAGE limits for a period of June 1, 2019 to May 31, 2020. The FIRE DEPARTMENT further agrees to clean and keep clean all the apparatus and equipment supplied to the FIRE DEPARTMENT by the VILLAGE, and to clean and keep clean the fire houses owned by the VILLAGE.

In addition, the Village further agrees to reimburse the Fire Department \$10,000 for expenditures incurred by the Fire Department in the event that total volunteer firefighters workers' compensation related expenditures are below \$60,000 for the period June 1, 2019 through May 31, 2020.

Whereas, the Board of Trustees concludes that it is in the interests of the taxpayers of the Village that the Village continue to require certain classes of paid elected officials, and their eligible dependents, to contribute to the cost of such coverage,

Now, therefore, be it

RESOLVED, that a certain resolution adopted by the Board of Trustees on August 5, 2015 with respect to the Village's policy regarding eligibility, and cost, of health insurance and life insurance coverage for paid elected officials and their eligible dependents be revised and amended, in the following respects, and it is further

RESO LVED, that any prior policy or resolution heretofore adopted by the Board of Trustees with respect to required contributions for health insurance and/or life insurance from present or former paid elected officials or their eligible dependents is continued in effect, except as otherwise provided hereinafter, and it is further

RESOLVED, that paragraph (b) of that certain resolution adopted August 5, 2015 is hereby amended, to read as follows:

(b) (i) Effective August 1, 2015, and continuing to and including May 13, 2019, persons holding paid elected office in the Village on or after March 29, 2011, who retire from or terminate such paid elected service after such date with at least ten years of such service in the Village may continue such health insurance coverage after retirement or termination of service, for themselves and for their eligible dependents, provided that such persons pay 10% of the Village cost of providing such coverage may receive such coverage if they pay or reim burse the Village for the cost of such life insurance coverage. Upon the death of any such person, the eligible dependents of such person may continue health insurance coverage on the same terms and conditions.

(ii) Effective May 13, 2019, persons holding paid elected office in the Village on or after May 13 2019 who retire from such paid elected service or whose paid elective service terminates after such date with at least nine years of such service in the Village may continue such health insurance coverage after retirement or termination of service, for themselves and for their eligible dependents, provided that such persons pay 10% of the Village cost of providing such coverage. Upon the death of any such person, the eligible dependents of such person may continue health insurance coverage on the same terms and conditions. Such persons who are eligible to receive life insurance coverage may receive such coverage if they pay or reim burse the Village for the cost of such life insurance coverage.

and it is further

RESOLVED, that paragraph (c) of that certain resolution be amended, to read as follows:

(c) (1) Effective August 1, 2015 and continuing to and including May 13, 2019, persons holding paid elected office in the Village on or after March 29, 2011, who retire from or terminate such paid elected service after such date with at least ten years of such service in the Village may continue such health insurance coverage after retirement or termination of service, for themselves and for their eligible dependents, provided that such persons pay 10% of the Village cost of providing such coverage. Such persons who are eligible to receive life insurance coverage may receive such coverage if they pay or reim burse the Village for the cost of such life insurance coverage. Upon the death of any such person, the eligible dependents of such person may continue health insurance coverage on the same terms and conditions.

(ii) Effective May 13, 2019, persons holding paid elected office in the Village on or after May 13, 2019 who retire from or such paid elected service, or whose paid elective service terminates, after such date with at least nine years of such service in the Village may continue such health insurance coverage after retirement or termination of service, for themselves and for their eligible dependents, provided that such persons pay 10% of the Village cost of providing such coverage. Upon the death of any such person, the eligible dependents of such person may continue health insurance coverage on the same terms and conditions. The Board discussed a resolution regarding the Village Length of Service award Program, which had been offered at the May 9, 2019 meeting, and with respect to which action had been deferred to the next Board meeting at which a quorum of eligible voters was present. On motion of Trustee Sepe, duly seconded by Trustee Grillo and carried by a vote of three to none the Board adopted the following resolution regarding abolishment of the existing Defined contribution Service Award Program, and the prospective establishment of a Defined Benefit Service Award Program, and authorizing a referendum with respect to the same, to be held at the June 18, 2019 general Village Election. Mayor Murray recused himself from discussion and vote on this item.

VILLAGE OF ROCKVILLE CENTRE BOARD OF TRUSTEES RESOLUTION

In the matter of abolishing the Villages current Defined Contribution Service Award Program and then prospectively establishing a Defined Benefit Service Award Program for active volunteer firefighter members of the Rockville Centre Fire Department

Whereas, a proposal has been made to prospectively replace the Village of Rockville Centre's Defined Contribution Service Award Program effectively established by the Village on January 1, 1994, as subsequently amended, with a Defined Benefit Service Award Program for active volunteer firefighter of the Rockville Centre Fire Department.

Now, Therefore, Be It Resolved That:

Section 1 The Board of Trustees of the Village of Rockville Centre, as authorized by Article 11-A of the New York State General Municipal Law, directs that there shall be a public referendum of eligible voters of the Village of Rockville Centre at the same time and place as the general Village election to be held on June 18, 2019, to determine whether the Village Board of Trustees shall:

- amend the defined contribution program effective January 1, 2020 to require a Participant to earn only one year of service credit to have his or her accrued Service Award become fully, 100% vested; and,
- 6. subject to the amendment in paragraph 1, above, abolish effective January 1, 2020

the Defined Contribution Service Award Program ("Defined Contribution Program"); and

- 7. pay to each person who was a participant in the Defined Contribution Program as of January 1, 2020 the entire vested portion of the balance in his or her Service Award Program account; and
- 8. establish a Defined Benefit Service Award Program as described in Section 219 of Article 11-A effective January 1, 2020, to financially reward volunteers for active volunteer firefighter service rendered after December 31, 2019,.

Section 2 All active volunteer firefighter members who are at least 18 years old, shall be eligible to become Defined Benefit Service Award Program Participants. Unless they waive participation, an eligible volunteer shall become a Participant on December 31 of the first calendar year after calendar year 2019 during which he or she earns a year of Service Award Program service credit. The names of the fire companies having volunteer firefighters who are potential participants in the Program are as follows:

- H. Eureka Hook Ladder & Bucket Co. No. 1
- I. Live Oak Engine Co. No. 1
- J. Alert Engine Co. No. 2
- K. Reliance Hose Co. No. 3
- L. Defender Hose Co. No. 1
- M. Woodland Engine Co. No. 4
- N. Floodlight Co. No. 1;

Section 3 The Defined Benefit Service Award Program shall be administered by the State of New York (i.e. the NYS Comptroller or the designee of the NYS Comptroller).

Section 4 Rockville Centre Fire Department active volunteer firefighter members shall have the opportunity to earn pension-like benefits as well as death and disability benefits under the Defined Benefit Service Award Program. The pension-like benefit, shall be a monthly lifetime payment accrued "Service Award" paid to a Participant with payments beginning after attainment of age 65 the "Entitlement Age," but not before a Participant earns at least one year of Service Award Program service credit for a calendar year after calendar year 2019. The monthly lifetime payment accrued "Service Award" shall be equal to \$20 for each year of Service Award Program service credit earned by a participating volunteer. The maximum monthly payment shall be \$600. Post age 65 active volunteers may be paid additional \$20 monthly lifetime service award payments for years of service credit earned after age 65. The participant may select any other actuarially equivalent forms of such monthly lifetime payments offered by the New York State Comptroller. In the event of the death of a Participant who had earned a nonforfeitable right to his or her earned service award before he or she attained the Entitlement Age, a lump sum death benefit shall, upon application, be paid to the Participant's designated beneficiary (or estate if no beneficiary is designated) and shall be equal to the discounted value at the time of death of the actuarial present value of the Participant's accrued Service Award. A Participant, who, before attaining the Entitlement Age shall be awarded benefit payments due to a total and permanent disability by the Social Security Administration or by any entity which pays benefits under the Volunteer Firefighters' Benefit Law or by any other authority approved by the New York State Comptroller, shall be eligible to be paid a pre Entitlement Age disability benefit payment under the Service Award Program. Such disability benefit payment shall be a lump-sum

payment to the Participant equal to the discounted actuarial present value of the Participant's accrued Service Award and be payable upon application by the Participant to and approval of payment by the New York State Comptroller.

Section 5 A Participant's accrued Service Award shall become fully vested (i.e. a Participant shall obtain nonforfeitable right to his or her accrued Service Award) after: he or she earns and does not permanently forfeit Service Award Program service credit for at least five (5) years of active volunteer firefighter service; or, attains age 65 while an active volunteer firefighter member; or, is awarded a Service Award Program total and permanent disability benefit payment.

Section 6 As of December 31 of the year a non-vested Participant ceases to be an active volunteer member of the Rockville Centre Fire Department, he or she shall forfeit any earned service credit and any accrued Service Award. The forfeited service credit and Accrued Service Award of a person who ceased to be an active volunteer firefighter member of the Rockville Centre Fire Department shall be restored if the person again becomes an active volunteer firefighter member of the Rockville centre firefighter member of the Rockville Centre Fire Department shall be restored if the person again becomes an active volunteer firefighter member of the Rockville Centre Fire Department within five years and subsequently earns at least one year of service credit under the Service Award Program Point System.

Section 7 A year of Service Award Program service credit shall be earned by an active volunteer firefighter for each calendar year after 2019 during which the volunteer earns at least 50 "points" while an active volunteer firefighter member of the Rockville Centre Fire Department for participating in the volunteer firefighter activities set forth by the Village Board of Trustees in the Service Award Program "Point System" as authorized by Section 217 of Article 11-A of the General Municipal Law, and during which he or she agrees to participate in the Service Award Program. A copy of The Point System is attached to this resolution. Copies of this written explanation of the Point System shall be distributed to active volunteer firefighters. The Village Board of Trustees may amend the Point System from time to time provided such amendments are allowable under all applicable statutes, rules and regulations. In the event the Point System is amended by the Village Board of Trustees, a written explanation of the changes shall be distributed to active volunteer firefighter members within 60 days of the date such changes are adopted by the Board of Trustees.

Section 8 Up to five years of the service credit earned by a Participant in the Rockville Centre Defined Contribution Service Award Program shall be credited for vesting purposes only (see Section 5) in the Rockville Centre Defined Benefit Service Award Program for volunteers who become Participants in the Defined Benefit Service Award Program in accordance with Section 2 of this resolution.

Section 9 Persons who continue to be active volunteer firefighter members of the Rockville Centre Fire Department after they attain the Entitlement Age shall have the opportunity to continue to earn service credit under the Point System. The additional Service Award payment earned by a Participant during a post Entitlement Age calendar year shall commence to be paid as of January 1st in the next succeeding calendar year.

Section 10 Under Article 11-A of the General Municipal Law, the Village of Rockville Centre shall be the Service Award Program "Sponsor".

Section 11 The New York State Comptroller or the designee of the New York State Comptroller shall be the Program Trustee.

Section 12 The annual cost including administration fees of the existing defined contribution program for current active volunteer firefighters can be as much as \$165,000 (\$700 per participating firefighter). The annual cost, first payable in calendar year 2021, of funding the proposed Defined Benefit Service Award Program for current volunteers is estimated to be as much as \$385,000 or \$1,650 per participating firefighter, including the cost of administration. The estimated annual cost to administer the Defined Benefit program for calendar year 2020 is \$8,500. The cost to terminate the existing Defined Contribution Service Award Program is estimated to be \$25,000.

Section 13 The Village of Rockville Centre Defined Benefit Service Award Program benefit payments shall commence to eligible volunteers on or after January 1, 2021 when they and/or their beneficiaries qualify, and apply, for payment in accordance with the Defined Benefit Program provisions set forth by the New York State Comptroller.

Section 14 All other provisions of the Village of Rockville Centre Defined Benefit Service Award Program shall be in accordance with Article 11-A of the General Municipal Law as amended from time to time and all applicable statutes and rules and regulations including those issued by the Office of The New York State Comptroller. Section 15. The foregoing provisions of Sections 2 through 14 of this resolution shall take effect only in the event the same are approved at a referendum to be held as described in Sections 1 and 16 of this resolution.

Section 16. The resolution to be voted upon at the said referendum shall read as follows:

"Shall the qualified electors of the Village of Rockville Centre approve the resolution adopted by the Mayor and Trustees on May 14, 2019 pursuant to Article 11-A of the General Municipal Law, to (a) effective January 1, 2020, abolish the existing service award program for members of the Rockville Centre Fire Department as such program previously was approved by the said electors on March 16, 1993, and as thereafter amended with the approval of the said electors, provided, however, that effective January 1, 2020 a participant who earns one year of service credit will obtain a non-forfeitable right to his/her accrued service award, and (b) effective January 1, 2020, establish a service award program which would be administered by the New York State Comptroller or the designee of such Comptroller, and would consist of a defined benefit plan as a service award. The project service award for the defined benefit plan is \$20 per month for each year of service credit, payable for life beginning at age 65. Post age 65 active volunteers may be paid additional \$20 monthly payment lifetime service awards for years of service credit earned after age 65. The annual cost, first payable in calendar year 2021, of funding the proposed Defined Benefit Service Award Program for current volunteers is estimated to be as much as \$385,000 or \$1,650 per participating firefighter, including the cost of administration. The estimated annual cost to administer the Defined Benefit program for calendar year 2020 is about \$8,500. The cost to terminate the existing Defined Contribution Service Award Program is estimated to be \$25,000."

Section 17. The appropriate officers of the Village of Rockville Centre are authorized to, and shall, take the necessary actions to implement and carry out this resolution.
