Mayor Murray introduced Trustee Baxley who congratulated the South Side High School girls from Dance Impress Studios under the direction of Coach Tawana Evens from the Dr. Martin Luther King Center. The girls preformed a dance for the audience and Trustee Baxley announced the girls won three  $1^{\rm st}$  place awards and are entering into the National Competition.

Mayor Murray introduced Trustee Baxley who presented and read a proclamation to the seniors from the Sandel Senior Centre acknowledging "Older Seniors Month".

Mayor Murray introduced Trustee Grillo who presented and read a proclamation to Kyle Mosher who became South Side High Schools first state wrestling champion since 1966. Trustee Grillo congratulated him on his achievements.

Mayor Murray introduced the President of the Lion's Club Ms. Joan McNaughton and thanked the Lion's Club for raising funds for Mr. B's all-inclusive playground. Ms. McNaughton presented a check to the Mayor for Mr. B's playground which was raised through fundraisers over the past year.

Mayor Murray introduced Trustee Sepe who presented and read a proclamation to the Molloy's College Men's Basketball team who won their first-ever East Coast Conference Championship. Trustee Sepe congratulated the men on their victory.
