Mayor Murray introduced the President of the St. Patrick's Committee Dennis Hoodak, Andy Healy and Ellen White. The St. Patrick's parade will take place on March 21<sup>st</sup> at 12:00pm. All net proceeds will be donated to the Rockville Centre Breast Cancer Collation, Army Ranger Lead the Way Fund and Holy Family School for the Deaf in Dublin, Ireland. In the last 23 years they have raised 1.3 million dollars for charity.

Mayor Murray introduced Trustee Howard who spoke about the St. Agnes Boys and Girls  $7^{\rm th}$  and  $8^{\rm th}$  grade basketball teams. Trustee Howard handed out certificates and congratulated them on their success.

On motion of Trustee Grillo, duly seconded by Trustee Howard and unanimously carried, the Board approved a contract with Duncan, Weinberg, Genzer & Pembroke, P.C. for legal services for the Village of Rockville Centre's portion of the New York Association of Public Power (NYAPP) from June 1, 2020 to May 31, 2021 in the amount of \$59,000.00, subject to the review of the Village Attorney as to form.

On motion of Trustee Sepe, duly seconded by Trustee Baxley and unanimously carried the Board approved additional funds in the amount of \$1,142.50 for H2M Architects, Engineers, Land Surveying and Landscape Architecture, D.P.C for laboratory services associated with the environmental assessment of the building at 142 Maple Avenue in preparation for the construction of the new Rockville Centre Police Department Headquarters.

On motion of Trustee Grillo, duly seconded by Trustee Baxley and unanimously carried the Board approved a Professional Service Contract with D & B Engineers & Architects, P.C. for engineering services for the 2020 Stormwater Management Program Services and MS4 Permit Compliance Activities, at a cost not to exceed \$11,600.00-.

On motion of Trustee Howard, duly seconded by Trustee Sepe and unanimously carried the Board approved a waiver of permit fees for a traffic signal communications project that Welsbach Electric Corp. of L.I. is performing for Nassau County as part of a larger communications project to improve traffic flows.
