RESOLUTION ADOPTING THE NASSAU COUNTY HAZARD MITIGATION PLAN

WHEREAS, all of Nassau County has exposure to natural hazards that increase the risk to life, property, environment and the County's economy; and

WHEREAS, pro-active mitigation of known hazards before a disaster event can reduce or eliminate long-term risk to life and property; and

WHEREAS, The Disaster Mitigation Act of 2000 (Public Law 106-390) established new requirements for pre and post disaster hazard mitigation programs; and

WHEREAS, a coalition of Nassau County municipalities with like planning objectives has been formed to pool resources and create consistent mitigation strategies within Nassau County; and

WHEREAS, the coalition has completed a planning process that engaged the public, assessed the risk and vulnerability to the impacts of natural hazards, developed a mitigation strategy consistent with a set of uniform goals and objectives, and created a plan for implementing, evaluating and revising this strategy; AND

WHEREAS, that planning process has generated a Nassau County Hazard Mitigation Plan, including a Village of Rockville Centre Annex, collectively referred to as the "Plan", which has been adopted by Nassau County on January 26, 2021; and

WHEREAS, the Board of Trustees of the Village of Rockville Centre finds and concludes that adoption of the Nassau County Hazard Mitigation Plan by the Village is in the best interests of the residents and taxpayers of the Village,

NOW, THEREFORE, BE IT

RESOLVED that the Board of Trustees of the Village of Rockville Centre hereby finds and concludes pursuant to the State Environmental Quality Review Act that the action herein taken has no significant adverse environmental impact, and that no further environmental impact review is required, and it is further

RESOLVED, that the Village of Rockville Centre:

- 1. Adopts in its entirety, the Nassau County Hazard Mitigation Plan (the "Plan") as the Village's Natural Hazard Mitigation Plan, including the Village of Rockville Centre Annex, and resolves to execute the actions identified in the Plan as they pertain to the Village;
- 2. Will use the adopted and approved portions of the Plan to guide preand post-disaster mitigation of the hazards identified;
- 3. Will coordinate the strategies identified in the Plan with other planning programs and mechanisms under its jurisdictional authority;
- 4. Will continue its support of the Mitigation Planning Committee as described within the Plan;
- 5. Will help to promote and support the mitigation successes of all participants in this Plan;
- 6. Will incorporate mitigation planning as an integral component of government and partner operations;
- 7. Will provide an update of the Plan in conjunction with Nassau County no less than every five years;

And it is further

RESOLVED, that the Village Administrator shall cause registration of the adoption of this resolution to be filed with appropriate agencies of Nassau County as required by the Plan.

RESOLUTION FURTHER EXTENDING LOCAL LAW 4-2020 MORATORIUM

WHEREAS, on September 14, 2020, the Board of Trustees of the Village of Rockville Centre duly adopted Local Law 4-2020, to implement a temporary moratorium on permits for certain signs or awnings; and

WHEREAS, the said Local Law was effective upon filing with the New York Secretary of State; and

WHEREAS, section three (a) of the said Local Law provided that the moratorium enacted by such Local Law would remain in effect for a period of thirty (30) days after filing of the Local Law; and

WHEREAS, the said Local Law was duly filed with the New York Secretary of State on September 18, 2020, by reason of which the initial duration of the moratorium was for the period of time to and including October 18, 2020; and

WHEREAS, section three (b) of the said Local Law provided that the Board of Trustees, acting by one or more resolutions, could extend the duration of the moratorium for additional periods of time not exceeding in total one hundred eighty (180) days; and

WHEREAS, the purpose of the said moratorium was to provide time for the Village Board of Trustees to consider and enact revisions to current Village Code provisions regarding authorized signs and awnings; and

WHEREAS, in the exercise of its authority under such Local Law, and in order to provide sufficient time for due consideration and drafting of legislation, the Board of Trustees heretofore extended the duration of the moratorium to and including February 15, 2021; and

WHEREAS, the Board of Trustees continues to consider drafts of such legislation, and concludes that the period of time to finalize that proposed legislation, hold required public hearing(s) and follow other required procedural steps before adopting such legislation requires that the moratorium be further extended as authorized by such Local Law,

NOW, THEREFORE, BE IT

RESOLVED, that the duration of the moratorium adopted by Local Law 4-2020, which currently expires February 15, 2021, be, and hereby is, extended for an additional sixty (60) days to and including April 16, 2021.

WHEREAS, if the Board does conclude that there is a need to do so, it is required prior to approval of the Village budget for that fiscal year to adopt a local law to authorize the Board of Trustees to override the tax levy limit; and

WHEREAS, in order to be in a position to adopt such a local law should it be determined to be necessary at the time of approval of the Village budget, the Village each year has initiated, but not necessarily concluded, the process of adopting a local law which would permit the Village to exceed the tax limit; and

WHEREAS, a public hearing is required for the adoption of such proposed local law, and a legal notice is required to announce the subject, time and place of the public hearing,

IT IS HEREBY RESOLVED that the Village Administrator shall cause a legal notice to be published in the next available edition of the official newspaper of the Village of Rockville Centre to announce that a public hearing will commence with respect to the proposed local law RVC 2021A on March 1, 2021 at 7:00 pm. and shall give such other notice of hearing as may be required by law.

WHEREAS, pursuant to EO 203, the Mayor caused to be convened the head of the local police department and community stakeholders, to develop such a plan, to consider each of the particular areas of concern required to be addressed, and to consult with interested other parties; and

WHEREAS, the foregoing consultation has included the local police force, members of the community, interested not-for-profit and faith-based community groups, the District Attorney, local public defenders and local elected officials; and

WHEREAS, as a result of such consultation, a draft plan has been prepared, and is to be offered for public comment, after which it must be presented to the Board of Trustees for adoption to take place on or before April 1, 2021;

NOW, THEREFORE, BE IT

RESOLVED by the Board of Trustees of the Village of Rockville Center, in order to timely solicit and receive such public comment, hereby directs that a public hearing with respect to such draft plan be held on March 1, 2021, at 7:00 pm, in conjunction with the regular meeting of the Board of Trustees to be held at such date and time; and it is further

Whereas, the Village and the EOC wish to memorialize that continued occupancy, and to revive, renew and extend the said Lease for a period extending to and including June 30, 2021;

Now, therefore, be it

RESOLVED, that the Board of Trustees, as Lead Agency pursuant to the State Environmental Quality Review Act and its implementing regulations, hereby finds and determines that the revival, renewal and extension of the said Lease is a Type II Action, as provided in 6 NYCRR 617.5(c)(32), which requires no further environmental impact review; and it is further

RESOLVED, that the Mayor, or his designee, is hereby authorized and empowered on behalf of the Village to execute an agreement between the Village and the EOC, in a form approved by the Village Attorney, to revive, renew and extend the said Lease for a term commencing July 1, 2020 and ending June 30 2021, otherwise on the same terms and conditions as the previous lease agreement for the term ending June 30, 2020.
