Whereas, as a result of a recent court decision regarding the circumstances under which such crash reports are governed, revisions to the existing service agreement are necessary; and

Whereas, a proposed revised agreement for the continued services of LexisNexis has been reviewed and recommended by Village staff, and approved by the Village Attorney as to form,

Now, therefore, be it

Resolved, that the Mayor, or his authorized designee, is authorized to execute a revised agreement with LexisNexis in the form approved by the Village Attorney.

On motion of Trustee Grillo, duly seconded by Trustee Howard and unanimously carried the Board adopted the following resolution authorizing the Deputy Village Justice Court under the supervision of the Village Attorney to consent to the institution and implementation of an amnesty program proposed by the Village Justices with respect to unpaid parking tickets, subject to the approval of the Village Attorney.

WHEREAS, the Board of Trustees has been informed that the Village Justices are considering implementation of an amnesty program with respect to unpaid parking tickets in order to dispose of a backlog of such tickets and to facilitate and improve collection of unpaid fines owed to the Village, and

WHEREAS, the Board of Trustees wishes to express its support for such an incentive program, and to authorize those attorneys who represent the Village as Deputy Village Attorneys in the Village Justice Court to consent to and participate in such program;
