Mayor Murray led the Pledge of Allegiance.

Mayor Murray started the evening by wishing Trustee Edward J. Oppenheimer a speedy recovery. Trustee Oppenheimer is resting comfortably after having a medical procedure on July 31, 2017. "Trustee Oppenheimer is an instrumental member of this Board, always working on behalf of our Village and residents".

Mayor Murray introduced Trustee Grillo; Trustee Grillo spoke on Karp Auto's 60th Anniversary celebration. Karp Auto is donating \$60.00 from every car they sell and up to \$60,000.00 which a percentage would be donated to the Memorial Sloan Kettering Breast Cancer Research and the Rockville Centre Community Fund. Mr. David Karp presented a check in the amount of \$5,000.00 to the Rockville Centre Community Fund, to thank and give back to the Rockville Centre Community for all their years of support.

Mayor Murray introduced Theresa Marigliano from "Come Together Yoga Studio" and Trustee Grillo spoke on her collaboration with MaryBeth Croutier to raise money for the RVC Conservancy. They meet every Sunday at the park for yoga classes and have raised \$770.00 from the students which will be donated to the RVC Conservancy for the tree program.

Mayor Murray introduced Kendall Kelly, Emmie McCabe and Thomas Doodian from the Mayor's Youth Task force. They are collecting nonperishable food for their "3rd Annual Mayor's Youth Task Force Back to School Food Drive", and the Hurricane Harvey food drive which will run from September 6th-12th. They will deliver the food to the St. Agnes Outreach Program and to the Hurricane Harvey food drive as well. Mayor Murray thanked them for all they do for the community of Rockville Centre.

Mayor Murray introduced Senator Todd Kaminsky who spoke on the "Liberty Medal Award" which is a state award that is given for the highest acts of valor, bravery and dedication. Senator Kaminsky presented the medals to two of Rockville Centre's finest, Chief Brian Cook and Christopher Bossert who saved a 53 year old man who was in cardiac arrest. Senator Kaminsky thanked Chief Cook and Christopher Bossert for their exemplary service.

Mayor Murray introduced Dr. Conellia Ha, Director of Radiology at Mercy Medical Center, who was pleased to announce a new standard of care for early breast cancer detection. Mercy Medical Center is the first in the state to offer LumaGem Molecular breast Imaging Technology which significantly improves early detection in women with dense breast tissue.

Mayor Murray renewed its commitment designating September as "Childhood Cancer Awareness Month" which is very dear to the Murray family. Mayor Murray introduced his wife Mrs. Barbara Murray whose niece Kimi Schroder has been fighting NeuroBlastoma for the last seven years. Trustee Baxley read a Proclamation presented to Mrs. Murray which recognizes the courage and compassion of children and families affected by cancer in the Village of Rockville Centre and the nation, and to help raise awareness of pediatric cancer and its victims.

Mayor Murray and Trustee Baxley introduced two residents of Rockville Centre; Mr. Dan Lennon and Mr. Rod McWalters. Dan Lennon is a dear friend of Mayor Murray and on October 30, 2016 at the RVC Links Golf Course Rod McWalters saved Dan Lennon's life when Dan went into cardiac arrest. Rod McWalters performed CPR on Dan Lennon at the 17th hole, and administered chest compressions until the paramedics arrived. Mayor Murray noted not only did Rod McWalters save Dan Lennon's life, but in September of 2012 Rod McWalters had been a bone marrow donor to a four year old boy named Zachary who lives in Michigan who was battling cancer. Zachary is now nine and his mother refers to Rod as their "hero".

Mayor Murray introduced Gregory Schafer from the Chamber of Commerce and thanked him again for the donation of the beautiful hanging flower baskets that are throughout the downtown area.

Mayor Murray introduced John O'Shea and Steven DiDomenico from Dee's Nursery. Together and on their own time, using their own material they installed the electrical and plumbing to create a beautiful waterfall on the corner of on Merrick Road and Lincoln Avenue. They built this waterfall because they wanted to give back to Rockville Centre. It is a great place to live, work and raise a family.

Mayor Murray introduced Trustee Sepe who spoke on the arrest of Mark Andrade in 2015-16. Due to his arrest by the Rockville Centre Police Department a DNA sample was entered into the NYS database and the sample matched DNA evidence that was recovered from a crime scene of an attack in New York City. Mark Andrade is being held on \$2,000,000.00 bond or \$500,000.00 cash bail.

Whereas, due to the application of GASB 54 principles, the said reserve funds have been classified as restricted fund balance on the financial statements of the Village, from which expenditures may be made for the payment of all or part of the cost of the monetary value of accumulated or accrued unused sick leave, holiday leave and vacation leave, due to a municipal employee upon termination of municipal employment and separation from service; and

Whereas, as a result of Police and Non-Police employee terminations during the fiscal year ended May 31, 2017 a resolution for an appropriation of \$150,000 from Employee Benefit Accrued Liability – Police Officers and an appropriation of \$150,000 from Employee Benefit Accrued Liability - Non Police Officers is requested;

WHEREAS, the United States Environmental Protection Agency ("EPA") and the United States of America, on behalf of the Administrator of EPA, contend that the EPA has claims for civil penalties and injunctive relief against the Village of Rockville Centre ("Village") pursuant to Section 113 of the Clean Air Act, as amended, 42 U.S.C. § 7413 et seq.; and

WHEREAS, the Village has disputed such claims and has engaged in discussions with EPA regarding those claims and possible resolution thereof; and

WHEREAS, in furtherance of such discussions, and to prevent otherwise unnecessary litigation, EPA has offered to withhold any litigation with respect to such claims if the Village would execute agreements to toll any applicable statute of limitations; and

WHEREAS, the Village Board of Trustees ("Board") heretofore has authorized several such tolling agreements, the most recent of which will be expiring shortly and which EPA has offered to further extend; and
