EDRB Case #28-2016 203 Merrick Road Holding Corp.

Building Superintendent Daniel Casella introduced McGuire Group Architect P.C. The property owner, South Nassau Communities Hospital, is seeking to convert and alter an office building for a medical building and access to parking lot, that is partially in a "Residential A District", not a permitted use, which requires thirty one, (31) parking spaces where twenty one, (21) are provided, and with front yard setbacks of 6 feet where 10 feet is required within a "Business A" zone. Premises know as 510 Merrick Road. The Board of Appeals has granted all require variances.

WHEREAS, the Village heretofore retained the services of Bruce Schwarting and Stephen Geraghty for personal services to consist of day to day management of the Staffing for Adequate Fire and Emergency Response (SAFER) Program for the then contemplated duration of that Program, for a period commencing November 25, 2012 and ending May 31, 2016; and

WHEREAS, the said Program has been extended to and including January 31, 2017; and

WHEREAS, the parties anticipate that the completion of documentation and other paperwork for the Program and its funding will require an additional period of time subsequent to January 31, 2017; and

WHEREAS, the Village wishes to retain the services of the said contractors, on the same terms and conditions for an additional period of time to permit completion of the Program and associated paperwork and documentation,

NOW, THEREFORE, BE IT

RESOLVED, that the Mayor is authorized to execute extension agreements in a form approved by the Village Attorney, extending the previous agreements with Bruce Schwarting and Stephen Geraghty for day to day management of the Staffing for Adequate Fire and Emergency Response (SAFER) Program, to be in effect for the period commencing with the conclusion of the prior such agreements through and including April 30, 2017.
