Mayor Francis X. Murray opened a Public Hearing for the purpose of reviewing the FY 2017 Tentative Budget, and requested that Village Comptroller Michael Schussheim proceed with the review. Mr. Schussheim presented the following Budget Message:

Fiscal Year 2017 Tentative Budget Message

If one were to ask the average NYS resident to explain the fundamental differences between the highly popular real estate tax cap and real estate tax freeze credit programs, you're likely to get a blank stare in return. Notwithstanding this unfamiliarity, it is fair to say that both programs have profoundly impacted the manner in which local governments develop their annual budgets. The tax cap program established a formula that ostensibly sought to limit real estate tax levy growth to the lesser of 2.0% or the rate of inflation. Certain exceptions were added to the formula that permit municipalities to exceed the 2.0% levy growth limit yet comply with the overall constraint in levy growth that was established by the program. The Village of Rockville Centre's FY2017 Tentative Budget containing tax levy growth of 2.0% complies with the limit established by the tax cap program.

The tax freeze credit is a two year real estate tax relief program that reimburses qualified NYS homeowners for increases in their real estate taxes. In order to be eligible for these cash reimbursements, homeowners must reside in a municipality where there is both complete compliance with tax cap program growth restrictions and the submission/approval of a government efficiency plan that demonstrates a minimum of 1% budget savings during fiscal years 2017, 2018 and 2019.

The Village of Rockville Centre is in compliance with both facets of the tax freeze credit program.

Earlier this calendar year, qualified Rockville Centre homeowners received a NYS cash reimbursement for the amount of growth associated with their FY2016 Village real estate taxes. This reimbursement represented the results from the first year of the tax

freeze program for Village governments. The limited growth in Village real estate taxes contained in the FY2017 Tentative Budget means that either later this calendar year or early next year, qualified Rockville Centre homeowners will be eligible to receive a NYS cash reimbursement during the second and likely final year of the tax freeze program.

Budget Summary

The total FY 2017 Tentative Budget amounts to \$43,569,634 which is an increase of \$375,769 or .87% above the FY 2016 Adopted Budget. The new real estate tax rate will be \$48.27 per \$100 of net assessed valuation, a 2.35% increase above the current real estate tax rate.

Assessed Valuation

Total net assessed valuation declined from \$59,636,027 to \$59,434,116. This represents a .34% reduction in net assessed valuation and a loss of \$97,462 in real estate tax revenues utilizing the Tentative Budget tax rate of \$48.27. Total net assessed valuation has declined 2.89% since FY 2012 when it totalled \$61,205,973.

Fund Balance

Current projections indicate that the General Fund will complete FY 2016 with a \$3,500,000 unassigned fund balance, none of which has been appropriated to the FY 2017 Tentative Budget.

Revenues

- Parking permit fees will generate \$1,230,000
- On Street Parking is anticipated to produce \$1,310,000
- Parks and Recreation charges are expected to total \$1,925,000
- Building Permit fees will generate \$1,050,000
- Fines and forfeitures will produce \$1,400,000
- Cable TV franchise fees are projected at \$659,000
- Mortgage Tax revenue is projected at \$430,000
- Transfers from the Electric & Water Funds will decrease to \$4,045,676

Expenditures

- Personal Services budgets reflect the salary levels contained in the CSEA Clerical Unit contract that expires on May 31, 2016 and the PBA contract that expires on December 31, 2016
- Retirement systems funding will total \$3,795,000
- Health Insurance appropriations equal \$5,142,000
- Debt Service expenditures will decline by \$63,647
- Sanitation Disposal fees are anticipated to total \$1,200,000
- Workers Compensation transfers will amount to \$900,000
