Local Law No. 1 - 2015

A local law to amend the Code of the Village of Rockville Centre, in relation to Substantial Occupancy permits.

Be it enacted by the Board of Trustees of the of Rockville Centre as follows:

Section one. Section 340-118.2(D) of the Code of the Village of Rockville Centre is hereby amended, to read as follows:

"D. The Zoning Board of Appeals shall have authority to grant Substantial Occupancy Permits required by this section. No Substantial Occupancy Permit may be granted by the Board of Appeals without a public hearing."

Section two. Any local law or provision of the Code of the Village of Rockville Centre in conflict with this local law is hereby repealed to the extent of such conflict, except that such repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of such local law, ordinance or resolution prior to the effective date of this local law.

Section three. If any clause, sentence, paragraph, section, article, or part of this local law shall be adjudged to be invalid by any court of competent jurisdiction, such judgment shall not affect, impair or invalidate any other part of this local law, or the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section, article, or part thereof directly involved in the controversy in which such judgment shall have been rendered.

Section four. This local law shall take effect immediately upon adoption and filing pursuant to the Municipal Home Rule Law.

Local Law No. 2 – 2015

A local law to amend the Code of the Village of Rockville Centre, in relation to permitted impervious surface coverage.

Be it enacted by the Board of Trustees of the Village of Rockville Centre as follows: Section one. Section 340-6(A) of the Code of the Village of Rockville Centre is hereby amended, to read as follows:

"A. For lots with area of 8,000 square feet or more, the principal building area shall not exceed 25%, and the total building area including accessory buildings shall not exceed 30%. For lots with area less than 8,000 square feet, the total building area including accessory buildings shall not exceed 30%. The impervious surface area of any lot shall not exceed 40%; provided, however, that sidewalks, swimming pools and entrance pathways that lead to a front door shall not be included in the calculation of impervious surface area for the purposes of this section. Notwithstanding the provisions of this paragraph, impervious surface coverage may exceed 40%, but shall not exceed 45%, where it is established to the reasonable satisfaction of the Superintendent of Buildings that the disposition of rainfall and other surface water will comply with standard engineering practices/calculations of water percolation, or that the property will provide drywells with sufficient capacity to retain and dispose of rainfall and surface water on site.)."

Section two. Any local law or provision of the Code of the Village of Rockville Centre in conflict with this local law is hereby repealed to the extent of such conflict, except that such repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of such local law, ordinance or resolution prior to the effective date of this local law.

Section three. If any clause, sentence, paragraph, section, article, or part of this local law shall be adjudged to be invalid by any court of competent jurisdiction, such judgment shall not affect, impair or invalidate any other part of this local law, or the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section, article, or part thereof directly involved in the controversy in which such judgment shall have been rendered.

Section four. This local law shall take effect immediately upon adoption and filing pursuant to the Municipal Home Rule Law.
