- 4. Upon pre-approval, an email will be sent notifying incentive and approved equipment. A completion document will shortly follow. For final approval, submit itemized invoices for installed equipment, equipment serial numbers and signed completion document.

- 6. Rebates up to \$3,000 per net kW reduced, and up to 80% of project costs. This offer is valid for a limited time only, and must not exceed \$25,000 (unless approved by a Rockville Centre Peak Savers program manager).
