Drives a three-person sanitation or recycling truck and acts as lead worker of the crew assigned to it or drives a two-person sanitation or recycling truck and collects commercial and residential waste or recyclable materials; performs related duties as required.

COMPLEXITY OF DUTIES

Under general supervision, when driving a three-person sanitation or recycling truck, the duties require the supervision of subordinates; when driving a two-person sanitation or recycling truck, the duties are repetitive and require the manual pickup and collection of waste or recyclable. For either truck, the duties also require the exercise of mechanical skill and judgment in the operation of automotive equipment. The work is reviewed for quality and completeness.

TYPICAL DUTIES

- * 1. Drives a truck on an assigned Sanitation or recycling collection route.
- * 2. Acts as lead worker of the crew assigned to the truck for the collection of waste or recyclable materials and, when required, assists them.
- 3. On two-person truck, picks up and loads waste or recyclable materials.
- * 4. Performs routine maintenance and servicing of the truck.
- * 5. Supervises and participates in cleaning and washing truck.
- * 6. Operates other types of motor equipment used for street and highway maintenance work, such as bulldozer, payload, snowplow, and sander, as required.

ADA ESSENTIAL FUNCTIONS*FULL PERFORMANCE KNOWLEDGES, SKILLS, AND ABILITIES**

1. Knowledge of the operation of automotive vehicles and motor equipment.
2. Knowledge of state and local laws and regulations governing operation of automotive equipment.
3. Knowledge of local sanitation collection routes.
4. Ability to drive sanitation or recycling trucks.
5. Ability to act as lead worker of a crew engaged in sanitation collection operations.
6. Ability to perform routine maintenance on automotive equipment.
7. Ability to perform physically arduous work.
