RESOLUTION AUTHORIZING NEGOTIATIONS AND EXECUTION OF AN AGREEMENT TO RESOLVE VARIOUS ISSUES BETWEEN THE VILLAGE OF ROCKVILLE CENTRE AND THE ENVIRONMENTAL PROTECTION AGENCY

WHEREAS, the Village of Rockville Centre ("Village") and the Environmental Protection Agency ("EPA") (represented by the United States Department of Justice "DOJ") have been engaged in extensive discussions regarding a Notice of Violation issued by the DOJ with respect to the Village power plant in 2012, and which Notice of Violation has been disputed by the Village; and

WHEREAS, the respective representatives of the Village, the DOJ and EPA have reached an understanding in principle, subject to being reduced to a written agreement to be executed by all parties, to settle and resolve all outstanding issues in such dispute ; and

WHEREAS, the EPA and DOJ have requested that the Village Board of Trustees manifest its understanding of the tentative terms of that settlement, before proceeding with further actions to reduce the tentative terms to a written agreement which will be executed by all parties to conclude the dispute; and

WHERAS, the Board of Trustees has been fully informed of the tentative terms of that settlement, and is in receipt of various inter- and intra-agency communications which outline the tentative terms and conditions thereof; and

WHEREAS, in order to induce the EPA and DOJ to continue such discussions, and prepare the agreement(s) necessary to fully conclude the settlement, the Board of Trustees adopts this resolution as a statement of its intent and understanding, and to facilitate the conclusion of this dispute upon the preparation of a mutually satisfactory agreement;

NOW, THEREFORE, BE IT

RESOLVED, that the Board of Trustees hereby expresses its understanding, and agreement, with the tentative terms of settlement which have been discussed among the parties to the aforesaid dispute; and it is further

RESOLVED, that the Board of Trustees authorizes the Superintendent of Electric, and Village counsel and special counsel, in conjunction with the representatives of the EPA and DOJ, to continue their efforts to reduce the tentative settlement to a written agreement, consistent with the terms outlined to the Board of Trustees in the aforesaid communications; and it is further

RESOLVED, that upon the completion of that written agreement, and confirmation from Village counsel and special counsel that the terms thereof are consistent with those outlined to the Board in the aforesaid communications, the Mayor or his designee is authorized to execute the said agreement on behalf of the Village; and it is further

RESOLVED, that upon the execution of that settlement agreement by all parties, and confirmation of the same from Village counsel and special counsel, all Village departments and personnel are authorized to take such actions as may be required by the terms of such agreement, in order to effectuate and implement the settlement agreement.

On motion of Trustee Grillo, duly seconded by Trustee Baxley and carried by a vote of four to none, the Board voted to close the executive session, return to public session and adjourn the meeting at 7:05p.m.

Mayor Murray spoke about the infrastructure upgrade that will protect the Village's water resources, which is imperative for the health and safety of the Villages residents and businesses. Mayor Murray introduced Senator Todd Kaminsky, who presented the Village of Rockville Centre with a check for \$2,100,000.00 from the NYS Water Infrastructure Improvement Act Grant. The funds will be used for the Village's new iron removal treatment plant, which will provide up to 5.6 million gallons of iron free water daily to Village residents. Mayor Murray thanked the Village's grant writer Suzanne Sullivan and the Village Engineer and Superintendent Kevin Reilly for all their hard work.

Mayor Murray introduced Trustee Grillo who spoke about South Side High School capturing the Nassau County Doubles Championship. Trustee Grillo called upon Julia Gentile and Lauren Zola and presented them with a certificate and congratulated them on their wonderful accomplishment.

Mayor Murray introduced Trustee Sepe who spoke on the Village of Rockville Centre receiving the S&P Global Rating of AAA which is the highest rating a Municipality can receive. Trustee Sepe thanked Village Comptroller Dennis Morgan and Village Administrator Kathleen Murray for all their hard work.

Village Administrator Kathleen Murray opened a Public Hearing regarding proposed Bill RVC 1809. After hearing all interested persons in attendance, on motion of Trustee Grillo, duly seconded by Trustee Baxley and unanimously carried, the Board voted to continue the Public Hearing regarding proposed Bill RVC 1809 until the January 7, 2019 Board of Trustees meeting.

On motion of Trustee Oppenheimer, duly seconded by Trustee Sepe and unanimously carried the Board authorized the Mayor or his designee to execute a grant agreement between the Town of Hempstead and the Village of Rockville Centre for a NYS Office of Children and Family Services grant in the amount of \$5,000.00-.

On motion of Trustee Oppenheimer, duly seconded by Trustee Baxley and unanimously carried the Board approved the expenditure for the Volunteer Fire Fighter Enhanced Cancer Disability Benefits Program for a cost not to exceed \$30,688.00, for basic coverage, with Volunteer Fireman's Insurance Service, Inc. (VFIS) pending legal review. The Board agreed that should enhanced coverage become available with VFIS during the policy year, at reasonable premiums and terms, the Village will give due consideration to adding that coverage; if VFIS enhanced coverage does not provide reasonable premiums and/or terms, the Village will give due consideration to adding that coverage with another carrier.

On motion of Trustee Grillo, duly seconded by Trustee Baxley and unanimously carried the Board approved extension of the Personal Services Agreement with D&K Consulting Services, Inc. in an amount not to exceed \$31,200.00 for approximately six months upon completion of current agreement.

On motion of Trustee Baxley, duly seconded by Trustee Grillo and unanimously carried the Board authorized an increase in the General Fund budget by \$17,495.00 to reflect a donation to Senior Services from FOSSI Inc.

On motion of Trustee Sepe, duly seconded by Trustee Grillo and unanimously carried the Board approved term sheets for the potential sale of cell site leases on the Village water tanks, and authorized the term sheets to be executed by the Mayor or his designee, in form to be approved by the Village Attorney.

On motion of Trustee Grillo, duly seconded by Trustee Baxley and unanimously carried the Board confirmed the contract with Springbrook Holding Company, LLC to allow the Village to accept credit card payments for electric bill payments.
