The Village has chosen to evaluate the number of outfalls screened for dry weather discharges as an indicator for measuring the overall effectiveness of the Village's compliance with the Illicit Discharge Detection and Elimination program requirements. The Village screened eight outfalls monthly for dry weather discharges during this reporting period. There were zero illicit discharges detected during the dry weather screenings.
