A local law to enact a temporary moratorium on certain building, zoning,

Section one. Findings. At the present time, there exist in portions of the Village of Rockville Centre Business A District various undeveloped or underdeveloped properties which are or may be the subject of development applications. Such development applications as are permitted under current zoning regulations of the Village may not be in the best interests of the Village, or the public health, safety and welfare of the residents of the Village. In view of such circumstances, and other factors and circumstances which indicate that review of possible future development in the Village would be appropriate, the Board of Trustees hereby finds and concludes that it is in the best interests of the public, including the residents of the Village of Rockville Centre, that a temporary moratorium be declared with respect to applications for and approvals of certain building and development activity in a portion of the Business A District, in order to permit the Village a reasonable opportunity to review and amend its zoning regulations and to prevent any person or property owner during such review from acquiring vested rights to undesirable development before any such amended zoning regulations could take effect.

Section two. Moratorium on Approvals. From and after the effective date of this law, and continuing for a period of time as set forth hereinafter, no application shall be processed or accepted, nor permit or approval issued, by the Board of Trustees, Zoning Board

of Appeals or Planning Board of the Village of Rockville Centre, or any other department, board or agency of the Village having jurisdiction over applications for construction or development of buildings or structures, or development of property, for any site plan approval, subdivision approval, building permit, special permit, zoning permit, variance, or other approval or permission (other than an extension of a period of time to complete a building or structure for which a permit has been duly issued prior to the effective date of this law) with respect to any proposed use or development of any building or structure in the portion of the Business A District hereinafter defined if the proposed use or development would involve or include the construction or development of a building or structure having a height in excess of one story. The areas of the Business A District in which the foregoing moratorium is to apply are (I) north of Sunrise Highway and between Oceanside Road and Long Beach Road, (II) along Long Beach Road north of the intersection of Oceanside Road and Long Beach Road, and (III) south of Merrick Road, east of South Kensington Avenue and west of Oceanside Road.

Section three. Duration of Moratorium. (a) The moratorium established by this law shall be effective until and including six months from the date of adoption of this law, unless sooner terminated as provided herein.

(b) Notwithstanding the provisions of paragraph (a) of this section, the Board of Trustees, by resolution adopted by a majority of its members, may extend the duration of the moratorium provided for herein for not more than two periods of three months each.

(c) Notwithstanding the provisions of paragraphs (a) and (b) of this section, the Board of Trustees, by resolution adopted by a majority of its members, may terminate the moratorium enacted by this law at any time prior to the expiration thereof.

Section four. Hardship; Exemptions. In any case where a property owner demonstrates to the satisfaction of the Board of Trustees that the provisions of this law, or the effects of this law, have created a financial hardship to such person, and demonstrates the existence of such financial hardship in the same manner and to the same extent as would be required to obtain a use variance from the Board of Appeals, the Board of Trustees, after public hearing held and noticed in the same manner as provided for a public hearing before the Board of Appeals, may grant an exemption from the provisions of this law, and by such exemption permit the appropriate board(s) or agency(ies) of the Village to process and/or consider any application, and in proper cases issue any particular approvals, which would otherwise have been subject to the provisions of this moratorium.

Section five. Any local law, ordinance, or resolution of the Village of Rockville Centre in conflict with this local law is hereby repealed to the extent of such conflict, except that such repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of such local law, ordinance or resolution prior to the effective date of this local law.

Section six. If any clause, sentence, paragraph, section, article, or part of this local law shall be adjudged to be invalid by any court of competent jurisdiction, such judgment shall not affect, impair or invalidate any other part of this local law, or the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section, article, or part thereof directly involved in the controversy in which such judgment shall have been rendered.

Section seven. This local law shall take effect immediately upon adoption and filing pursuant to the Municipal Home Rule Law, and shall be applicable to all permit or other approval applications subject to this law which are pending on the date of adoption of this law or filed during the effective period of this law.
