Section one. Section 340-144 of the Code of the Village of Rockville Centre is hereby amended, by adding thereto a new paragraph, to be paragraph C, to read as follows:

“C. The Board of Trustees of the Village of Rockville Centre hereby exercises its authority pursuant to Municipal Home Rule Law §10(1)(ii)(e)(3), to supersede and amend Village Law § 7-706(5) in its application to the Village of Rockville Centre, and with respect to the Village of Rockville Centre such section 7-706(5) shall read as follows:

‘5. Filing. Every zoning law and every amendment thereto (excluding any map incorporated therein) adopted pursuant to the provisions of this chapter shall be entered in the minutes of the village board Such minutes shall describe and refer to any map adopted in connection with such local law or amendment.’”

Section two. Any local law or provision of the Code of the Village of Rockville Centre in conflict with this local law is hereby repealed to the extent of such conflict, except that such repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of such local law, ordinance or resolution prior to the effective date of this local law.

Section three. If any clause, sentence, paragraph, section, article, or part of this local law shall be adjudged to be invalid by any court of competent jurisdiction, such judgment shall not affect, impair or invalidate any other part of this local law, or the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section, article, or part thereof directly involved in the controversy in which such judgment shall have been rendered.

Section four. This local law shall take effect upon adoption and filing pursuant to the Municipal Home Rule Law.
